

#### A WORD FROM CHIEF SARAH S. CHANNING





Thank you for entrusting me with the responsibility of being Chief of the Seneca-Cayuga Nation. It is an honor to serve as the first woman chief of our great Tribe. I am committed to working with the Business Committee and including every Seneca-Cayuga citizen as we work for the success of our Nation. We may not always agree on policies, but we have common ground. I believe everyone reading this newsletter has a desire for our Nation to flourish. We are unified in this belief! I am confident we can all work together for a prosperous future.

The Seneca-Cayuga Nation's future is bright, but we do face challenges. I cannot overstate the impact of COVID-19 on Tribes across the country. As a Nation, we have lost several members to the disease. Revenue at Grand Lake Casino is down as a direct result of COVID-19, which means there is less money to pay benefits and fund other programs. Despite the challenges, we are fortunate. We do not have high levels of debt or overhead expenses. The leadership at Grand Lake Casino has adapted to the challenges of COVID-19. For example,

Grand Lake Casino recently launched the "One Casino... Three Ways to Play" initiative. Three ways to play gives guests options to play in areas of the casino focused on safety with masks required, or in more traditional areas, with masks optional. This is just one way we are developing new strategies to compete in today's casino market. We are already seeing an increase in customer traffic as a result. Despite decreased revenue, we have avoided layoffs, and we continue to pay benefits as money is available. Seneca-Cayuga Nation staff have shown resilience as they adapt to working from home when necessary.

The upcoming election is an opportunity for every Seneca-Cayuga citizen to have a say in the direction of our Nation. In January, we will be electing four out of seven Business Committee members. I encourage you to read each of the biographies in this newsletter carefully. When you vote, choose people you believe can help our Nation prosper for the sake of future generations. Please make voting in the upcoming election a priority in your schedule.

I am hopeful. We must be unified in order for us to come out of this difficult year as a stronger Nation. I look forward to gathering as a community at the ceremonies, which are critical for our spiritual health. I am hopeful that COVID-19 will recede, and Grand Lake Casino will reach new heights in financial contribution to the Nation. I am encouraged that many of us are preparing for a better future by continuing our education, even under challenging circumstances. We all still face difficulties from COVID-19 and its effects, but as we face those challenges together, I know that the coming year will be better for all of us.

#### A SPECIAL ELECTION OF THE SENECA-CAYUGA NATION'S ELECTED OFFICERS WILL BE CONDUCTED ON JANUARY 30, 2021.

Those positions include Second Chief, Secretary-Treasurer, 2nd Council Person and 4th Council Person.

The term of office for these positions will be January 30, 2021 to June 4, 2022. This is to re-establish staggered elections.

All Tribal members who are 18 years of age or older on January 30, 2021 and are on the Tribal rolls, are eligible to vote and should receive an official ballot from the election administrator.

The ballot process will be by mail in ballots only. No walk-in ballots will be accepted.

This process will be handled by an independent election administrator engaged by the Business Committee

# 2021 Election

On January 30, 2021 the Seneca-Cayuga Nation will hold an election for the positions of Second Chief, Secretary-Treasurer, 2nd Council Person and 4th Council Person. Every Seneca–Cayuga person who is 18 years or older will be able to vote and have a say in who leads our Nation. This year's election will be conducted by mail-in ballot. Using a mail-in ballot will ensure everyone has equal access to the polls. Voting by mail is simple, but there are a few essential things to know as you prepare to vote.

#### **GETTING YOUR BALLOT:**

Ballots will be mailed to every eligible voter. An eligible voter is anyone who is 18 years or older on the day of the election and is listed on the rolls maintained by the Enrollment Department. You do not need to request a ballot. Your ballot will be mailed to the address on file at the Enrollment Department.

If your ballot does not arrive, or arrives damaged, please contact Leslie McCoy by calling 918-791-6027 or e-mail Imccoy@sctribe.com.

#### **COUNTING THE VOTE:**

The third party election administrator, Election Trust, will count the vote. Employees from Election Trust will have access to the PO box that ballots are mailed to. No one else will have access. On January 30th, 2021, employees from Election Trust, supervised by the Election Committee, will open the PO box. Ballots will be securely transferred to the Community Center for counting. Ballots will be counted by the election administrator, under the Election Committee's supervision, and observed by representatives for each candidate.





#### **VOTING INSTRUCTIONS:**

Voting is simple. Follow the instructions included in the packets to fill out the ballot and voter affidavit. Here are the steps:


- 1. Fill in your ballot and seal it in the blue secrecy envelope.
- 2. Place the sealed blue secrecy envelope in the provided return envelope. Do not seal the return envelope.
- 3. Complete the affidavit. It must be notarized.
- 4. DO NOT put the affidavit in the blue secrecy envelope.
- 5. Place the affidavit in the provided return envelope.
- 6. Seal the return envelope.
- 7. Mail your ballot through the United States Postal Service.

Your ballot must arrive at the post office box listed on the return envelope before 11:00 am on January 30, 2021. Please mail your ballot early.

The address on the return envelope is a post office box set up specifically for the election. The post office box can only be opened by the third party election administrator. Ballots must arrive in the post office box before 11:00 am on January 30, 2021. Ballots that arrive after 11:00 am on January 30, 2021, will not be counted. Please mail your ballots early to ensure they arrive on time. You must use the return envelope provided. If you send your vote in a different envelope or using different forms, it will not be counted.

There will be no in-person voting for this election. If you want to vote, be sure and mail in your ballot.

I am a descendant of Tribal ancestors that have held unique significant leadership roles in the History of the Seneca-Cayuga Tribe of Oklahoma. I am the great-great granddaughter of the late James Logan, the last traditional hereditary head Chief of the Oklahoma Cayuga's, Granddaughter of the late David "Uncle Babe" Logan who was a traditional faith keeper or "pot-hanger" the majority of his life, and daughter of the late Frances "Jackie" LoganBirdsong.

It has been my honor to have previously served on the Business Committee 10 years with four years as Second Chief, and 6 years as Councilperson. Through that experience

I have learned a lot regarding the issues facing the Tribe. I believe as an elected official all decisions made should be based on how the outcome will affect the people today, as well as generations yet to come. Upholding and honoring the Constitution and By-Laws along with General Council directives; as they were set in place to give us guidance, they MUST be followed.

We should safeguard all tribal and federal programs to ensure funds are allocated appropriately. Creating new businesses will offer more employment opportunities along with revenue for Tribal programs. The education program and guidelines need to be reevaluated to better serve the needs of our tribal members. Ensuring that resources are available to provide services for all qualified members, in addition offer guidance in researching other avenues to gain assistance.

Communication is a MUST in order to provide good leadership along with accessibility and accountability. All Business Committee members should equally be provided with all information regarding the Tribal business at hand in order for the Tribe to move forward and make the best decisions for the Tribe and future generations. I understand the importance of open communications.

It is important that we support, acknowledge, and work together with our Traditional people, and all those who take interest in learning and preserving the culture and language. It is important that we support things like Tribal Language Classes and such in their efforts at passing the ways on to our young so that our Tribal customs and Ceremonies will continue on into the future. I pledge to honor our elders, children, and all members of the tribe, and treat all members fairly.

#### JERRY CROW - CANDIDATE FOR SECOND CHIEF



I grew up in Oklahoma. There was a period of three years during his youth that my family spent in Los Angeles in support of my father's work in the airline industry. The stay was reasonably brief, however, moving back after 3 short years to Broken Arrow, Oklahoma. His grandfather, Jerry Crow, was the Chief of the Seneca-Cayuga Nation tribe in the early 1900's. My great uncles were Amos and Moses Crow, who played a critically important part of history by signing the treaty from Abraham Lincoln keeping the Confederates away from the Iroquoian Indians.

I attended undergraduate school at Spartans School of Aeronautics in Tulsa, Okla. where I pursued a bachelors' degree on a program funded by the Bureau of Indian Affairs. From there, I continued onward through my professional career, and completed 20 years of work within the oil and gas industry, serving and leading on teams that developed proficiency with robotics and mechanics.

For the last 27 years of my career, I worked with Tulsa Technology School on the

operations and engineering of production technologies. I worked on every aspect of machinery throughout the plant until he retired from the organization in 2014.

"I want to be remembered as an honest man that followed the rules. I want to see the Seneca-Cayuga nation children be successful, pursue a job, and pursue a sustainable career. I want to see our community more independent. I want every member in our community to have access to education, while learning about a world reaching even beyond Seneca- Cayuga Nation boundary lines."

My vision is as follows: "There is a big world out there, and there exists a lot of opportunity. Our members could be a massive part of developing needed solutions to the problems of the world. What if we lived in a way that would foster a culture of higher employment numbers, of academic achievements and developed solutions? As the keeper of all tribal monies, records, documents, and as Chairman of the Enrollment Committee, this position requires complete transparency and accountability to ALL Seneca-Cayuga Tribal Members, while maintaining the appropriate confidentiality demanded by the position. As a concerned tribal member, I have been committed to increasing communication and transparency between the members of our Nation and our leadership. Through social media and email, I have informed tribal members about vital information and provided explanations of proposed constitutional changes from the Business Committee, which are often vague or confusing. Our people deserve to have all the necessary information to make informed decisions. If elected as Secretary-Treasurer, I pledge to continue my commitment to communication and transparency through an absolute open-door policy. I will keep tribal members abreast of the actions and decisions of the Business Committee, as well as the state of the tribe.

One of the most pressing issues in our tribe is the enrollment of our babies and kids. The Secretary-Treasurer acts as the Chairman of the enrollment committee and has a duty to ensure that new member applications are handled appropriately and in accordance with the constitution and the tradition built over the past 80+ years as a tribe. As Secretary-Treasurer, I will work diligently to ensure that all our babies and kids, who have been denied for years, are approved for membership and brought before the General Council.



#### LEROY HOWARD - CANDIDATE FOR SECRETARY/TREASURER



My name is LeRoy Howard and I would appreciate your vote for Secretary/Treasurer of the Seneca/Cayuga Nation. As many of you already know I was a councilman for 4 years, the tribal Business Manager for 13 years and the Chief for a total of 9 years. The Secretary/Treasurer has had the duties called out in our Constitution and By-Laws, many of them have been ignored. Some of these duties are obvious, like record the meetings, make out the order of business, have custody of the records and papers, keep a correct list of all members of the Council. One very important duty – Shall receive all moneys of the Council and keep accurate accounts of receipts and disbursements. I believe the tribal membership has the right to know what these receipts are and how they are being spent. We now have no idea and haven't for years, known about our income or how it is spent. If I become secretary/Treasurer I will have a monthly report on those funds. Another historical duty of the Secretary/Treasurer is to act as Chairman of the Enrollment Committee, which has historically, more than 40 years that I can remember, consisted of

former Secretary/Treasurers and a few elders. As Chairman of this very important committee, which has largely been inactive due to the practice of having only one person making the decision on who is and isn't a tribal member. Our Constitution is very clear on how and who is to be a member. One part requires the vote of the Council. We have not had a General Council meeting in over 6 years, so there must be hundreds of people in limbo. We used to have around a hundred applications presented to the General Council each year for its consideration. We have not had a General Council meeting in over 6 years due to underhanded actions of those in charge. This policy of shutting down GC meetings and not recognizing an eligible applicant has affected their eligibility to use the Indian Health care as well as the general services the Tribe has provided in the past. If elected as Secretary /Treasurer I will end this practice and activate the important Enrollment Committee and get all eligible applications before the General Council.

Again, I would appreciate your vote for Secretary /Treasurer. LeRoy Howard


I was honored to serve as the Seneca-Cayuga Nation's Secretary-Treasurer in 2013,

There's only so much local revenue and we have hit that wall and now must consider the "new bar" for Gaming in this State, and that is destination Gaming Facilities. We now have Riverbend Casino and Hotel, Indigo Sky Casino Resort and the Cherokee Nation right in our backyard. I believe we must step up to the plate or watch our Gaming Revenues continue to dwindle and share what customers are left with the Cherokee Casino in Grove. As far as our Tobacco facility we should consider expansion of product lines and reconsider the export market. CDB is an excellent start and we should consider an enhanced focus on that entire industry.

There is a lot to do and I want to help. I ceased the travel assignments and rearranged my life to provide an improved quality of life for my special needs child and to care for my Mother in her golden years; and I couldn't be more grateful to have been able to do so. So I am here, I am available at all times and equipped to do the Job. rv,ost importantly, the Constitution and the respect thereof, are my primary goals. There shall never be another Council Meeting that does not respect Parlimentary Procedure, the Constitution and the Civil Rights of The People. My name is Stephan Michael Crow and I am announcing my candidacy for the office of 2nd councilperson of our great Seneca-Cayuga Nation. Unlike other candidate's I have never been convicted of a felony. I was born in 1969 in Tulsa, Oklahoma. I am the youngest of 6 siblings of the wolf clan from Lester and Donna Crow. Many of you knew my father and how great, hard-working, and fun he was providing for his family as a mechanic for American Airlines after serving our country during the Korean War. He planted the seed of serving and caring for others I have today. My uncle Vernon Crow served as our chief for 10 years. My great grandfather John Crow was chief in the 1920s. The Crow family has a long history of serving others and our great nation.

I am much like my father spending my spare time serving others for the last 20 years. Helping start a Celebrate Recovery to building homes for Habitat for Humanity and Joplin tornado recovery. I have been a member of Church on the Move for 15 years now. I started serving at Dry Gulch USA as a volunteer consultant, welding supervisor, and during Christmas Train season as a video engineer serving 50,000+ people. I am

currently on the production team as a video engineer after running a camera for years. My men's discipleship group serves the greater Tulsa area reaching out to those in need. We helped spearhead the relocation of the Reed Foundation by joining with the City of Tulsa renovate the Ben Hill Community Center that keeps children and young adults off the streets.



### **Frequently Asked Questions**

### When is the election?

The Seneca-Cayuga Nation election will take place on January 30th, 2021. The election will be conducted by mail. There will be no in person voting. Ballots must be received by 11:00am on January 30th, 2021 or they will not be counted.

### How will votes be cast?

All votes will be cast via absentee ballot. The absentee ballots will be mailed to all registered members of the Seneca-Cayuga Nation that are 18 years of age or older. Members will fill out the ballots and mail them back to a third party election auditor. Ballots must arrive in the post office box before 11:00 am on January 30th, 2021. Ballots that arrive after 11:00 am on January 30th, 2021, will not be counted.


