BE NOT LESS THAN TWENTY-FIVE YEARS OF AGE

BE A MEMBER OF THE SENECA-CAYUGA TRIBE OF OKLAHOMA, AND

RESIDE WITHIN A 150 MILE RADIUS OF THE BASSETT GROVE STOMP GROUNDS

ALL BURDEN OF PROOF OF QUALIFICATIONS ARE THE SOLE RESPONSIBILITY OF PROSPECTIVE CANDIDATE.
