Declaration of Candidacy Filing

Any qualified member of the Seneca-Cayuga Tribe who wishes to be placed on the ballot as a candidate for office must file the Declaration of Candidacy Form with the Election Administrator at the following address:

The Declaration of Candidacy Form must be filed in writing and In-Person. Candidates may file their Declaration on the following schedule:

Saturday, March 30, 2013 8:00AM - 1:00PM

(NO EXCEPTIONS)

The filing candidate is solely responsible for providing all documentary evidence, the \$250.00 nonrefundable filing fee, and their notarized Declaration of Candidacy form. (The filing fee must be paid by Certified Check or Money Order made payable to the Seneca-Cayuga Tribe. Cash will NOT be accepted)

Voting on Election Day

Voters may cast their ballots on Election Day, between the hours of 8:00 a.m. and 3:00 p.m. at the Tribal Community Building 24805 South 660 Rd., Grove, Ok 74344.

Absentee Voting

If you are an eligible voter of the Seneca-Cayuga Tribe of Oklahoma and will be away on Election Day, you may vote by Absentee Ballot. To receive an Absentee Ballot, you must request one in writing. To request an Absentee Ballot, you must complete and return by mail an Absentee Ballot Request Form.

Voters desiring to request an Absentee Ballot may complete and return the enclosed Absentee Ballot Request Form. Voters may also obtain an Absentee Ballot Request Form;

- **All Absentee Ballot Request forms must be submitted by mail!**

Please follow instructions for completion of the form carefully and include all requested information. You must sign your name and give your full address, including zip code. Voters may only request a ballot for themselves. Absentee Ballot Request Forms must be received by the Election Board via U.S. Mail no later than Thursday, May 2nd, 2013 at 11:00 a.m..

Absentee Ballots must be received by mail in the Election Board Post Office Box no later than Friday, May 31st, 2013 at 11:00 a.m.. Absentee Ballots will not be accepted In-Person by the Election Board or at the polls on Election Day.

LeRoy Howard
Candidate for Chief

I was born July 14, 1945 to tribal member Geraldine Bearskin Howard Stovall.

Roy Stovall, also a tribal member, was my stepfather. I grew up in the local area and have always been involved in the Tribal Traditional Ceremonies. I have always lived in the Tribe's reservation area and have lived in the same house for nearly 40

years and will live there the rest of my years. I have been married to my wife Sharon for over 47 years. We have three children, eight grandchildren, and one great grandchild.

I am a veteran of the United States Army with service in Vietnam. I attended Northeastern Oklahoma A&M College in Miami, Oklahoma and then attended Missouri Southern State College in Joplin, Missouri, majoring in Business Administration with emphasis in Marketing, Management and Economics.

Serving as Business manager of the Seneca-Cayuga Tribe from early 1977 through mid 1990 I wrote nearly a dozen grants and contracts each year and was responsible for the administration of those programs. The Tribe had unprecedented progress in an organizational manner, providing services for Tribal Members, and constructed several Tribal Buildings. I was also very involved in the establishment of the Health Clinic and the Housing Authority.

I previously served two terms as Councilman on the Tribal Business Committee and as Chief for nine years. During the past 37 + years I have developed friendships and working relationships with many Tribal Leaders across Indian country, with Political and Governmental Leaders of all different levels, and made many business contacts throughout the country.

I feel that my experience in business and years of service within the Tribe has prepared me to provide the guidance and leadership to achieve the full potential of our Sovereign Nation.

If re-elected Chief, I pledge to defend our Nations' Sovereignty, to protect the Nation's assets and assure that all official actions in the course of governing the Nation are based upon well thought out plans that ensure near term objectives are achieved, tangible returns are realized, and long-term expectations are met. While guarding the assets of the Nation, I will also guard against frivolous and uninformed actions.

I pledge to protect the Constitutional Rights of all Tribal Members that they may express opinions regardless of whomever they agree or disagree with, to treat all Tribal Members fairly, to encourage and assist our people in all ways possible, and to address all Tribal Members in a respectful manner.

I pledge to continue to strive for the respect that our Tribe has had while participating in the community of tribes to achieve mutual goals of independence and self-sufficiency.

I pledge to bring Statesmanship, Leadership and Integrity to our Nation, which will guarantee a stable and prosperous Seneca-Cayuga Government. With experienced leadership our Nation will prosper and our People can enjoy a better opportunity for a happier life.

It is an honor to serve as Chief of the Seneca-Cayuga Tribe and to serve all our Citizens.

I am the great, great grandson of Charlie Bigtail Hubbard, the great grandson of Florence Hubbard, the grandson of Leroy Wabaunsee and the son of Sandra Kingston. My roll # is 241-2; my great grandmother Hubbard had the very first roll number in the pre-1937 government issued roll #'s.

Hello and thank you for taking the time to read my biography, and any and all other candidates biography's as well. I was born and raised in Grove and have always felt fortunate to be afforded the luxury of being right here in our Oklahoma Territory and Headquarters for The People. Upon Graduation from Grove High School I completed my Associates in Arts degree at Northeastern Oklahoma A & M and entered the private sector work force immediately upon completion. I spent the next fifteen years in the commercial fitness industry in sales, sales management, regional and eventually district management with multiple statewide and national chains including All American, International, Bally's, American Super Clubs and more. I have worked with other Tribes and Native Peoples brokering services for the groups I have listed and I worked on projects with retired Senator Enoch Kelly Haney when he was Chief of the Seminole Nation. I have spent much time in our homeland, mostly in the Eastern Door in Mohawk Territory. I assisted in the development stages of a class II facility and authored the KKGK gaming regulatory act for the Kanienkehaka Kanonhsesne Mohawk Nation, an aboriginal Nation, and in the process was fortunate to have the intervention by the aboriginal's in the ongoing dispute between our Nation and the New York Cayuga Nation. I can help facilitate bringing our Nations back together as one and am asking for your help in doing so. Change begins the first Saturday in June with your help, which starts with casting your vote. If you choose me to lead this Nation I will include everyone, and that means everyone..... by first and foremost, live feeds of all meetings. It will also include electronic filing of all resolution's, by-laws, ordinances and whatever else deemed necessary public (Tribal) information. If I can 'close the gaps' that facilitate any and all miss-management and/or malfeasance's...I will consider that my greatest achievement in starting the path for responsible government.

Schrimpscher Whitetree; my grandfather Ogle Whitetree.

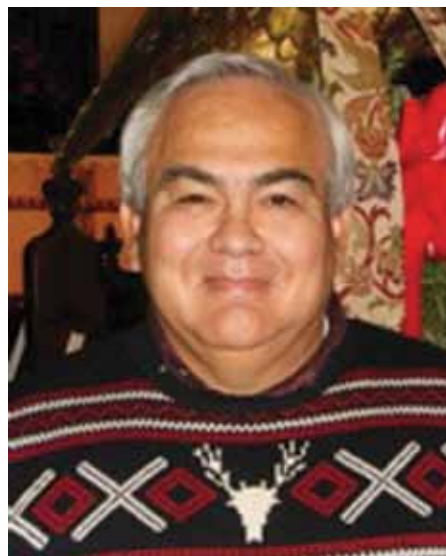
I have two children; Christopher Burch and Shannon Roach. My husband Randy and I follow our traditional ways and participate regularly in our ceremonies.

Candidate for Business Committee, Third Position

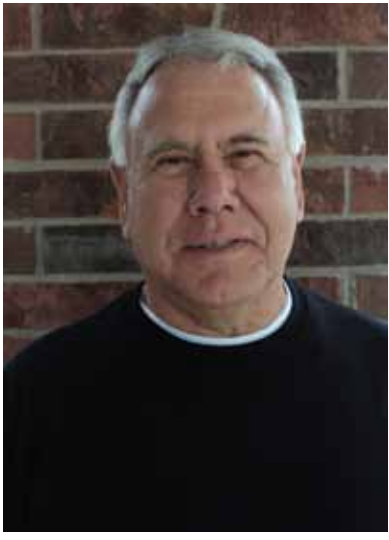

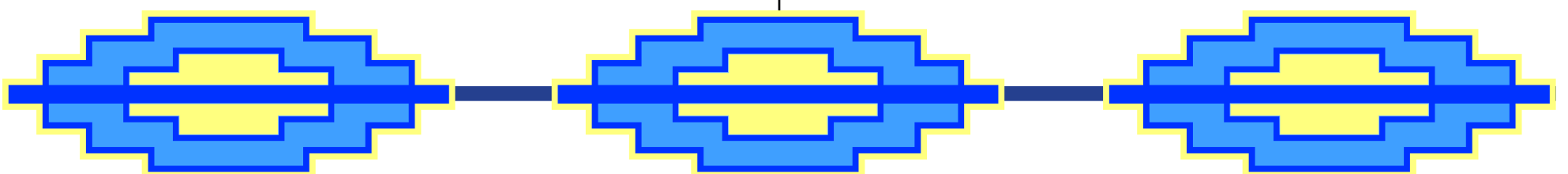


Diana Baker

My son Preston and his wife Abby have my beautiful granddaughter Sophie.

If you elect me as 5th Grievance Committee Member I assure you I will do what is best for the tribe and tribal members with fairness and respect to everyone. Thank you in advance for your support.
